### SHOTS BY CEO PHOTOGRAPHY SESSION TERMS AND CONDITIONS

## 1. Booking and Confirmation

- 1.1 To secure your session, a non-refundable deposit of \$50 is required at the time of booking.
- 1.2 Full payment for the session is due on the day of the session or as otherwise specified in the contract.
- 1.3 Once payment is received, the session will be confirmed and scheduled.

# 2. Cancellations and Rescheduling

#### 2.1 Client Cancellations

- If the Client cancels the session more than 48 hours before the scheduled date, the deposit may be transferred to a rescheduled session, at the Photographer's discretion.
- If the Client cancels within 48 hours of the scheduled session, the deposit will not be refunded.

## 2.2 Photographer Cancellations

 In the unlikely event the Photographer needs to cancel or reschedule due to illness, weather, or unforeseen circumstances, the Client will be given the option to reschedule or receive a full refund of payments made.

#### 3. Session Arrival and Time Limits

- 3.1 The Client is responsible for arriving on time for the scheduled session. If the Client arrives late, the Photographer will attempt to accommodate them, but the session may be shortened. The session fee will not be adjusted for lateness.
- 3.2 Session time includes preparation and breaks. Time spent beyond the agreed-upon session duration will be billed at an additional rate per hour.

#### 4. Image Delivery

- 4.1 The Photographer will provide the Client with edited images within a timely manner following the session.
- 4.2 Images will be delivered via online gallery. The Client will be given access to these images for personal use w/ 5 edited images of the client's choice.
- 4.3 Additional images or requests for edits may incur an additional charge, as specified in the contract.

## 5. Copyright and Usage Rights

- 5.1 The Photographer retains full copyright of all images captured during the session.
- 5.2 The Client is granted a personal-use license to the images for non-commercial purposes, including printing and sharing on social media with proper credit to the Photographer.
- 5.3 Any commercial use of the images, such as selling or advertising, requires the Photographer's written consent and may involve additional fees.

#### 6. Model Release

- 6.1 The Client agrees to allow the Photographer to use images taken during the session for promotional purposes, including but not limited to: portfolios, websites, social media, and marketing materials.
- 6.2 If the Client does not wish for their images to be used publicly, a written request must be made prior to the session. A separate model release form may be provided if needed.

# 7. Client Cooperation

- 7.1 The Client agrees to cooperate with the Photographer by following the agreed-upon shoot schedule, locations, and any other reasonable instructions given to ensure a successful session.
- 7.2 If the Client or anyone involved in the session interferes with the Photographer's work, the Photographer reserves the right to end the session early, and no refunds will be provided.

#### 8. Liability and Safety

- 8.1 The Photographer will take reasonable precautions to ensure the safety of the Client during the session. However, the Photographer is not responsible for any accidents, injuries, or damages that may occur during the session.
- 8.2 The Client assumes full responsibility for the safety and well-being of themselves and others during the session.

## 9. Travel and Additional Fees (If applicable)

9.1 If the session takes place outside the Photographer's local area, travel fees will apply, including transportation, accommodation (if necessary), and meal costs. These fees will be communicated to the Client and agreed upon in advance.
